Equally FSMS ISO 22000 extends HACCP MS for an organizations to address a full management system. To assure that the quality of foods and services is concurrent with best-in-class safe foods expectations, organizations can opt to integrate QMS ISO 9001—ISO 15161 with ISO 22000 and other programs. This provides for one assessment addressing both safe and quality of foods.

Environmental management systems certification provides one of our cornerstones and strength, as we provide ISO 14001 and European EMAS (Environmental Management Audit Scheme) certification.

ISMS provides our basis for certification in Reference to ISO/IEC 27001 as well as Port Security SMS 28000.

OSHMS provides Occupational Health & Safety certifications in accordance with BS OHSAS 18001, ILO-OSH, 29 CFR 1910 and equivalent national regulatory schemes.

Social Accountability certification is based on the principles of SA8000, CSR (Corporate Social Responsibility), and as Guidance applying ISO 26000.
